Dr Bolitho - PhD UNSW, B.A (Hons,Sociology) UNSW, Grad.Dip.Science (Psych) USYD - is a social scientist trained in the disciplines of psychology and sociology. With a particular focus on restorative justice, restorative practices, violence and conflict resolution, her work is empirically based and aimed at directly informing current criminal justice policy.

Dr Jane Bolitho of UNSW will share her vision of restorative justice, and provide a brief overview of research completed on NSW post-sentence RJ focusing on how victim needs underpinned best practice and research on magistrates' perceptions of therapeutic jurisprudence and restorative justice in the children's courts. Jane will explore what we can draw from restorative models that also assist at other stages of the criminal justice process.
